## 2) Election of Secretary/Recorder

- a. Heidi Sanger was nominated (Chip Watts), seconded (Bryant Brown), and unanimously approved.
- 3) 90 Day Plan Summary Cassie Kapes
  - a. Reviewed goals:
    - i. Social Emotional Learning
      - 1. Morning Meeting Implementation
        - a. Walk throughs completed with specific feedback and coaching and needed
        - b. Morning Meeting is a tool to provide social emotional learning to all students every day, as well as to build community in classrooms and in the school. This year we are infusing the evidence-based Second Step curriculum into the Morning Meetings. Chip noted that others coming into the school continually note the difference in the school climate from a few years ago.
        - c. Summary: The majority of teachers are implementing the elements in their morning meeting routines.
    - ii. Math Student Achievement
      - 1. Explicit Vocabulary and Envision Math Block
        - a. Reviewed data, which has resulted in adjusting the end of year goal for this year to, "60% of students will reach their expected level of growth as measured by Acadience in math and reading and fluency."
        - b. Can the end of year goal be changed if we achieve it in the middle of the year? Yes!

c. The SMART Goal is for the 90 day plan to reach the end of year goal.

Discussed what parents can do at home to support their children's learning. It was noted that things like a Career Fair can be meaningful to students because they are often visual learners. Our Career Day is coming up on November 22 which will be an opportunity.
